MALAYSIA VOLUNTEERS CORPS (AMENDMENT OF SCHEDULE) ORDER 2013

IN exercise of the powers conferred by subsection 22(2) of the Malaysia Volunteers Corps Act 2012 [Act 752], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Malaysia Volunteers Corps (Amendment of Schedule) Order 2013**.

(2) This Order comes into operation on 22 September 2013.

Amendment of Schedule

2. The Malaysia Volunteers Corps Act 2012 is amended by substituting for the Schedule the following Schedule:
